The September 9th milonga party receipts of \$616.00; after costs of \$610.06, it produced a net gain of \$5.04. Total attendance: 57(39 regular members, five non-members, 13 free entries: one DJ, and eight membership dues related, two Gatekeepers and two additional workers.) September 2023 revenue from the weekly practica series was \$751.00 with \$584.23 in expenses for a net gain of \$166.77. There were 103 attendees during the month - an average weekly 26 attendees. Membership revenue totaled \$315.05.

- 5. October milonga OCT 14 Venue Four Seasons; MUSIC-Bob Barns; MC-Gerry; Gatekeepers Rob and Joe; Food Dan N.; PR Terri
- 6. Discuss a TSoM Microgrant/Loan program to provide seed money (e.g., up to \$250 per event, and maximum \$3k for one year) to stimulate and support non-board-initiated tango events and activities, e.g., Friday Night Milongas, Sunday Milongas, etc. (Eduardo) Carried over.
  - We have a grant policy in place that hasn't been advertised for a few years. Eduardo would like to see more Fri and Sun milongas.
  - Fran wants TSoM to create a grant committee of up to 3 people, that would be in place before someone asks us for a grant. Eduardo, Jack, Gerry, and Rob volunteered.
  - Gerry will send a grant policy draft to the whole board.
- 7. Gala Committee update (Fran, Eduardo, Terri, Mary Pearl, Janeen, Rob)

  The entertainment and venue have been secured. Pricing will be the same as last year which includes parking, some decisions were made about format of event with regards to available space. Eduardo will send out another "Save the Date" next week and remind people to renew TSoM memberships to get the best price. Start and end time music 7:30-10:30. There will be a place for socializing, passed appetizers, before dancing begins. Plans are in flux.
- 8. Timetable for Nominating committee in motion, nominating committee members will meet in early Oct. TSoM News has been sent announcing the start of the nomination process.
- 9. CINE LATINO Oct 15
  - Paola oversees Cine Latino; we are partnering with them. We will have a dance demo lasting 20 minutes after the movie concludes. It will be in conjunction with a large Spanish festival party being held before the final film. Fran proposed we supply food for 60 people; she said we can order empanadas from Del Sur w/Maria's 20% discount, \$35/dozen, proposing 4 dozen. Jack suggested we forget empanadas and make donation for lessons for new people. Fran said last time she spoke with Paola; they were seeking a demo and lesson (in 20 minutes). There may not be 20 minutes for Diana's demo. Diana will be paid (\$75) and empanadas will be (4-5 dozen at \$35 each).

MOTION: We support Cine Latino by purchasing 5 dozen empanadas at \$35/dozen. Motion passed with one abstention. We decided to do a demo and not have Diana provide a lesson. Fran will communicate with Paola and Diana.



- 10. U of MN Tango Class every year a new class of tango students from the U come to a TSOM milonga either in October or November. Andrea and Rebecca provided a list of 19 students to give them free entrance. List will be at the gate.
- 11. TSoM Newsletter Bill Boyt sent an email saying he'd like to see TSoM return to preparing and send by mail "Tango Moments", which was a multipage newsletter. He asked if the TSoM board would like to join him in putting this together. Comments:
  - Cost of paper, email have gone up, need more funds for a budget,
  - Some people think it's a good idea, some not.
  - Need to know who is going to be on next year's board before starting a new project.
  - Could ask him to put a proposal together on the financial aspect.
  - Many organizations have stopped sending paper newsletters and use their website or email for newsletter.
