



MEMBERSHIP STATISTICS REPORT March 25, 2024: Total Members



This is Gerry's first draft for "seed" grants to TSoM members for new activity development. Susan mentioned that we might consider rolling grant applications instead of once or twice a year. Susan clarified the use of the term "rolling" to accept an application in a reasonable time. Rob recommended that
