1. **Consent Agenda.** Susan moved to approve the June Agenda except for the Membership/Practica/Milonga Stats report and June Financials as they are yet outstanding. Jennifer seconded the motion. Motion Approved.

Treasury report will be sent to all board members in the next couple of days followed by the Membership/Practica/Milonga report, as the Treasury report is required to complete the Membership reports.

### 2. Communication/Tech (Carl)

Club Express needs a physical address (not a PO Box) for internal purposes. Currently, we are using Gerry's address and email. It will be best to change to TSoM treasury email. When a new president is put in place, we will need to input the new President's name and physical address into Stripe (Club Express). The address is not public facing and is used to send physical invoices.

Gerry uploaded TSoM meetings of 2025 to the Club Express Website. FYI: Documents need to be uploaded from a desktop. Document Folders can be configured for layered access (members only, admin, etc.) Will make minutes & bylaws visible to members only.

Gerry and Carl will continue to test payment systems. The next working session will include how to use Club Express at the Milonga to check people in. Club Express has a mobile app as well.

Jennifer will create a point list for tasks, such as Membership Database, Volunteer Solicitation, etc. The standing Monday meeting will be used for working sessions.

Fran, Mariola, and Bill Boyt will be added as members to help test.

Emails from Club Express: Club Express works differently than mail chimp. Carl will research and document the process.

## 3. Membership Report (Susan)

The Membership committee proposes a summit which will include these topics:

• How do organizers want (or not) TsoM to partner with them.

- How can TsoM support organizers in scheduling events to avoid conflicts and overly short respites between events to ensure success for all.
- How do we ensure there is a solid foundational landing point for beginning classes?

It would be beneficial to hire a professional mediator for the event. Susan has a lead on a mediator.

Susan moved to approve the idea and empower the next steps, including involving the board. Gerry seconded the motion. Motion approved.

## **Executive Summary**

**Practica:** We had a total of 140 attendees across four Practicas in June. Of these, thirty were non members, accounting for 21% of our attendance. Revenue was a total of \$705 in a

combination of mostly cash and PayPal. The expenses totaled \$94.34 for a guest instructor payment of \$70 and 17.43 for mints and 6.91 for PayPal expense. We concluded the month with a positive balance of \$603.75. So far in 2025, Practica revenue totals a net positive of \$1178.34.

**Milonga:** The June Milonga had higher than average costs due to the number of musicians (\$850) and the recognition checks (\$405) for local milonga organizers. Total costs were \$1803.18. Attendance was also higher than average with a total of forty-seven members and sixteen non-members in attendance, bringing attendance to sixty-three people, with 25% being non-members. Total revenue for the Milonga was \$821. Milonga revenue totals a net negative of \$982.18 for the month of June. It should be noted that we are running a \$3651.99 deficit in the Milonga category.

**Membership:** In May, we had eleven membership payments\$. Membership revenue was a net positive of \$260.04 after accounting for \$14.96 in fees charged by PayPal. So far in 2025, membership revenue totals a net positive of \$1555.08.

**Admin Expenses:** In June, we had several admin expenses totaling \$1154.53. Most of this expense was related to Club Express. We had minor expenses for MailChimp and checkbooks.

**Gala:** There were no additional Gala expenses in June. Our investment in the 2025 Gala so far this year is \$1800.
